Public Lecture by Professor Dale Jorgenson on "Pricing Carbon in China, the United States, and the World Economy"

公開講座:戴爾·喬根森教授主講「中國、美國與世界經濟體的碳定價」

Professor Dale Jorgenson, Samuel W. Morris University Professor at Harvard University, presented a lecture titled "Pricing Carbon in China, the United States, and the World Economy" on 4 August. In view of the impending implementation of a national carbon emissions trading system in China, Professor Jorgenson elaborated upon this scheme of pricing carbon and explored the possibilities of extending the system's coverage to encompass other greenhouse gases. He remarked that such an extension would entail combining a tax on other emissions of carbon and its equivalent with a system of tradable permits for fossil fuel combustion, and this hybrid system would supplement China's effort to fulfil its commitments under the United Nations Framework Convention on Climate Change.

Professor Jorgenson has conducted groundbreaking research on information technology and economic growth, energy and the environment, tax policy and investment behavior, and applied econometrics. His 1963 article, "Capital Theory and Investment Behavior," was chosen as one of the twenty most outstanding papers published in the first 100 years of the American Economic Review. In 1971, he received the prestigious John Bates Clark Medal of the American Economic Association. Professor Jorgenson was President of the Econometric Society in 1987 and served as President of the American Economic Association in 2000.



哈佛大學 Samuel W. Morris 講座教授戴爾·喬根森於 8 月 4 日演講,講題為「中國、美國與世界經濟體的碳定價」。鑒於中國即將實施全國碳排放交易體系,喬根森教授詳細闡述該碳定價機制,並探究延展系統以涵蓋其他溫室氣體的可能性。他表示這項延伸需要將其他碳排放物及其等同物的稅收與化石燃料燃燒的可交易許可證制度相結合,而這混合系統將有助中國履行其在《聯合國氣候變化框架公約》下的承諾。

喬根森教授對資訊技術和經濟增長、能源與環境、稅收政策和投資行為,以及應用計量經濟學進行了突破性的研究,其在 1963 年發表的文章《資本理論與投資行為》被選為《美國經濟評論》前 100 年最傑出的二十篇論文之一。他於 1971 年獲頒美國經濟學會著名的約翰·貝茨·克拉克獎。喬根森教授曾分别於 1987 年及 2000 年擔任世界計量經濟學會和美國經濟學會主席。

Luncheon Talk by Professor Jiang Yi-huah on "The Predicament of Cross-Strait Relations and Its Politico-Economic Impacts"

午餐講座:江宜樺教授主講「兩岸關係困境及其政治經濟影響」

In the luncheon talk held on 26 September, Professor Jiang Yi-huah, former Premier of the Republic of China (Taiwan), discussed the political quandary confronting Taiwan. The talk, titled "The Predicament of Cross-Strait Relations and Its Politico-Economic Impacts", contrasted the attitudes of two presidents, Ma Yingjeou and Tsai Ing-wen, towards the 1992 Consensus and delineated the subsequent political conflict between China and Taiwan. He further expounded the ensuing political and economic impacts as well as the dilemma Taiwan faced.

Professor Jiang served in various capacities of the Taiwan government, including the Minister of Research, Development and Evaluation Commission, the Minister of the Interior, the Vice Premier, and the Premier of the Republic of China (Taiwan). During his public service years, he launched the master plan to streamline the central government, facilitated the development of e-commerce and social enterprise, increased the national income per capita and reduced the unemployment rate, as well as passed a series of strict regulations regarding environmental protection and food safety. Professor Jiang was a visiting scholar at Harvard University and the Hoover Institution as well as a research fellow at Stanford University.





在 9 月 26 日舉行的午餐講座中,前中華民國行政院長 江宜樺教授探討台灣所面臨的政治困局。是次講座題為 「兩岸關係困境及其政治經濟影響」,江教授對照了馬 英九及蔡英文這兩位總統對「九二共識」的態度,並論 及中國與台灣後來的政治衝突。他更進一步闡述了這導 致的政治和經濟影響,以及台灣面對的兩難境地。

江教授曾在台灣政府擔任多項要職,包括行政院研究發展考核委員會主任委員、內政部部長、行政院副院長及院長。他在任公職期間,推行了簡化中央政府的總體規劃,促進電子商務和社會企業發展,提高國民人均收入,降低失業率,並通過了一系列嚴格的環境保護和食品安全法規。江教授曾為哈佛大學和胡佛研究所的訪問學者,以及史丹福大學的研究員。

Public Lecture by Mr. Cui Yuzheng on "Investment Opportunities and Credit Risk Management Strategies in Mainland Chinese Markets under the "New Normal"

公開講座:崔玉征先生主講「新常態下,內地債券市場投資機會和 信用風險管理策略」

On 6 July, Mr. Cui Yuzheng, Vice President of Frontline Financial Services, delivered a lecture titled "Investment Opportunities and Credit Risk Management Strategies in Mainland Chinese Markets under the "New Normal". Taking account of the ongoing medium-to-low growth of the Chinese economy under the "new normal" as well as incidents of material default transpiring in Mainland's capital markets, Mr. Cui elucidated how to effectively assess the credit risk of bond issuers and formulate investment strategies attaining a match between risk and reward. Mr. Cui is responsible for the quantitative risk management and high-yield bond investment of Frontline Financial Services; the scale of the latter amounts to 10 billion dollars. He served in bond

investment and credit risk management positions at Moody's, Ping An Securities and Essence Securities.

深圳正前方金融服務有限公司副總裁崔玉征先生於 7 月 6 日主講題為「新常態下,內地債券市場投資機會和信用風險管理策略」的講座。崔先生在考慮到中國經濟持續中低速增長的"新常態",以及內地資本市場發生債券實質性違約的情況下,闡釋如何有效地評估發債主體的信用風險並制定風險收益匹配的投資策略。崔先生負責正前方金融服務有限公司的量化風險管理與高收益債券投資,後者規模達 100 億元。他亦曾在穆迪、平安證券及安信證券擔任債券投資和信用風險管理的職位。
